WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely St. Ann's College of Education, Sarojini Devi Road, Secunderabad-500003, Andhra Pradesh vide (NCTE) order No. F.AP/B.Ed./10/SRO/NCTE/2000-2001/2257 dated 01.11.2000 for conducting (Secondary) B.Ed. Course of one-year duration with an annual intake of 112 students.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 22.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 12.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 150 (three basic units) from the academic session 2015-16.
- AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 28.02.2019. The institution has submitted reply of Show Cause Notice on 26.04.2019
- AND WHEREAS, the SRC in its 402nd meeting held on 13th & 14th September 2021 considered the matter and committee decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 08.10.2021. The institution has submitted reply of Final Show Cause Notice vide letter dated 09.11.2021.
- AND WHEREAS, The SRC in its 412th meeting held on 05th 06th July 2022 has considered the matter and decided to issue a Last Reminder Letter. Accordingly, as per the decision of SRC, a Last Reminder Letter was issued to the institution on 26.07.2022. The institution vide letter dated 08.08.2022 & 05.09.2022 has submitted a reply to the Last Reminder Letter and requested for 2 units B.Ed. Programme.
- AND WHEREAS, the SRC in its 414th meeting held on 26th & 27th September 2022 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time considered by the SRC and the following observations were made were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution St. Ann's College of Education, Khasra No. 9-1-82/1 Sarojini Devi Road, Secunderabad-500003, Telangana for B.Ed. programme for 2 basic units of 50 students each."

- NOW THEREFORE, this order is issued permitting the institution i.e. St. Ann's College of Education, Khasra No. 9-1-82/1 Sarojini Devi Road, Secunderabad-500003, Telangana run by The Sisters of St. Ann of Providence Central Province, Khasra No. 9-1-82/1 Sarojini Devi Road, Secunderabad-500003, Telangana for continuation of recognition for B.Ed. Programme for two years duration (2 basic units) of 50 students each subject to fulfillment of the following
  - I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfill all such other requirements as may be 8. prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government
- The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a
- The institution shall maintain its Website with hyperlink to the Council and the Southern 10. Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information, if it so desires. i.
- Any false or incomplete information on website shall render the institution liable i. k. for withdrawal of recognition.
- The institution shall adhere to the mandatory disclosure in the prescribed format and 11. display up-to-date information on its official website.
- The institution shall make available the list of students admitted on its official website. 12.
- The institution shall fill the information on GIS Portal on the NCTE Website. 13.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
